7. Narrative Description

This is a two story, three bay, brick commercial building with Italianate influence, constructed in 1890. Historically, the address was typically 214 W. 2nd Street, as depicted on the Sanborn maps. The first Sanborn map to show a structure here (1892) shows a three story building here, as is depicted in the 1891 *Souvenir of Muscatine, Iowa* (Holmes 1891). Originally, it was similar to the earlier adjacent building, including a similar cornice. The 1899 Sanborn map shows that the building height was reduced to two stories, perhaps suggesting a fire in the 1890s soon after the construction. The existing cornice dates to this early period of modification.

The storefront retains its original cast iron columns. The original storefront configuration shown in the 1891 book had a double-door entry between two large storefront windows and the upper story entry to the right. The storefront openings have been replaced and modified with smaller features, with the additional space covered by wood paneling. Non-historic awnings are centered above the non-historic door and windows. The storefront frieze and cornice appears to be metal with brick accents along the bottom. The second story includes three two-over-two-light double-hung windows with painted stone hoods and sills. These hoods are nearly identical to those on the neighboring building at 212 W. 2nd St. The brick and metal cornice is decorative with arch detailing and dentils across the frieze. Metal finials mark either end of the cornice.

The west elevation includes four segmental-arch windows on the first floor that have been filled-in with wood. There is a historic segmental-arch entry that is partially filled-in with wood roughly in the middle of the elevation. Towards the alley there is a segmental-arch basement window filled-in with wood. This elevation also includes a painted business sign that is non-historic, possibly dating to the 1970s when the paint store moved into this location. The second story includes three double-hung wood windows with segmental arch lintels.

The south elevation includes two segmental-arch basement windows filled-in with wood. There is also a historic entry filled-in with wood, one window closed with an iron shutter, and another window covered with wired mesh. The first story includes three windows with segmented arched lintels; one covered by an iron shutter, the other two are historic made with wood. All these windows have iron sills. The second story has three windows with segmented arched lintels. One window is closed by an iron shutter; the other two are historic made of wood, with an iron shutter on one of the historic windows left open. The windows on the second floor all have iron sills. There is a recently added metal cornice and frieze.

8. Narrative Statement of Significance

This building appears to be individually eligible under Criterion A for the National Register of Historic Places for its association with the pearl button industry. Additionally, it does appear to be a contributing building in a potential downtown historic district.

This building appears to be individually eligible for the National Register of Historic Places under Criterion A for its association with the Muscatine Pearl Novelty Company (later the Muscatine Pearl Works). As the pearl button industry grew in Muscatine, a side industry also began, the pearl novelties. This was the first company that focused primarily on these products, though it was joined by competitors in the early 20th century. It continued to be a prominent company within the pearl button industry throughout the first half of the 20th century. This business continued to operate through 1962, also making it one of the longest businesses of this kind in Muscatine. Though the building has some storefront modifications, it certainly retains sufficient integrity to convey this aspect of its history. The reduction in height of the building from three to two stories occurred prior to the time that the Muscatine Pearl Works moved here. Though it retains several characteristics of the Italianate style, there are several examples of this style in downtown Muscatine. This building is a late example of this style, and with the storefront modifications it does not appear to be a particularly outstanding example of this style. Additionally, it is not particularly associated with a prominent person. Thus, it does not appear eligible for the National Register of Historic Places under Criteria B or C.

Finally, this structure appears to be a contributing building in a potential downtown historic district. It falls within three contexts identified for the district: "Pearl Button Center of the World," "19th century Business and Industry," and "20th century Business and Industry." Its history with the pearl novelty business is contributing to the downtown district, as well as its overall contributions to the commercial and industrial history of the district.

The building was constructed in 1890; it first appears in the city directories in the 1891-1892 edition, as the Fred Daut Grocery. The building historic address was typically 214 W. 2nd Street, though it has been variously listed in city directories and Sanborn maps as 214, 216, 218, and 220 West 2nd Street. The building first appears on the Sanborn map in 1892 as a three story building, which is depicted in the 1891 *Souvenir of Muscatine, Iowa* (Holmes 1891). Originally, it was similar to the earlier adjacent building (212 at the time) also owned by Fred Daut, including a similar cornice. The 1899 Sanborn map shows that the building height was reduced to two stories, perhaps suggesting a fire in the 1890s soon after the construction. The existing cornice dates to this early period of modification.

From 1890 until 1900, according to the city directories, this was home to the Fred Daut Grocery. This was next door to his cigar and tobacco business at 212 West 2nd Street. The 1892 and 1899 Sanborn maps depict a wholesale grocery business in both 212 and 214 (now 218) W. 2nd St. This was one of several grocery businesses in this potential district. Fred Daut was not any more well known or significant to Muscatine history than any of the other grocers in this potential district.

The building was empty for a few years, and the Muscatine Pearl Novelty Company moved here by 1907, according to city directories. The Muscatine Pearl Novelty Company was started in 1898 making hat pins, pearl stick pins, pearl buckles, and pearl slides in a small shop on Mulberry Avenue, employing around a half a dozen people. The variety of items made and production increased, and the company moved to W. 2nd St. The 1905 Sanborn map shows that the office was located on the first story, with the cutting and finishing room on the second story. By the 1912 Sanborn map, the first story was used for the office, soaking, cutting, and finishing, while stock was stored on the second story. The name of the

company was changed in 1920 to the Muscatine Pearl Works, and incorporated as such. In 1935, after O.A. Hammer became president, modern button manufacturing equipment was added along with the trade name, Luckyday ("Muscatine Pearl Works" 1940: 54). The company expanded again in 1939 by setting up additional space across the street at 227 West 2nd Street, and then in 1943 they expanded again into 208 and 206 West 2nd Street. After a fire destroyed their building at 227 West 2nd Street on October 1, 1961, the company moved all their operations to Highway 61 South (Muscatine Fire Department). In 1968, they moved to 1103 Musser Street where they remained until 1985 when they went out of business (Pearl button pamphlet file 1). The Muscatine Pearl Novelty Company, later Muscatine Pearl Works, was the first company to be involved in the pearl novelty business, and it was also the largest.

After being vacant about a year, Central Industries located here in 1964. Central Industries was a small manufacturer of office furniture, started by a former employee of HON (HNI) Industries, Bill Duval. In the early 1970's Hills Fair-All Paint Store located here and is still here. The painted signs on the south elevation possibly date to this period.

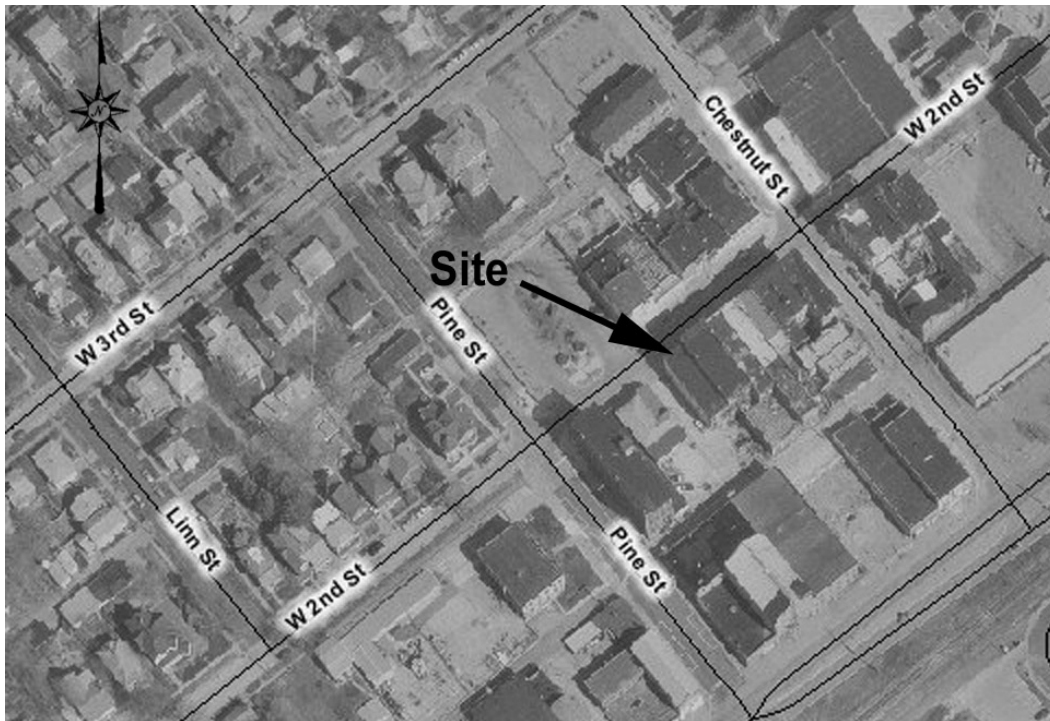

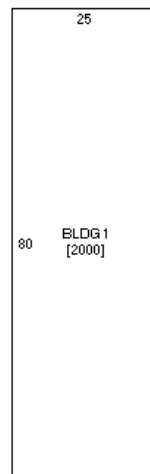
