7. Narrative Description

This building functioned primarily as a two story bake house and oven for 201-203 W. 2nd for most of its history since around 1885. The front one-third of the building is the original brick structure, and the rear concrete block two-thirds represents an addition from around 1925 when the building ceased to serve as a bake house.

The east elevation of the building has been clad in non-historic steel siding. The façade roof line is straight across most of the building, sloping at the south side. This section likely represents a side addition to the building also clad in the metal façade, and this section has a garage door and pedestrian door. The east (front) one-third of the north elevation along the alley is brick and the west two-thirds of this elevation is concrete block. The brick portion of the wall is obviously older and has three bricked in segmental arch openings. The west opening appears to be a doorway as it runs to the ground level. The opening just to the east of the bricked in doorway appears to be a window set up high. No sill is evident. The eastern most opening is a small bricked in window or oven opening set at ground level. The north elevation has a metal door set up high with loading stoop just to the west of where the brick transitions to concrete block. The south elevation is visible from within a courtyard, and it is concrete block and has windows at the west corner of the elevation set high in the wall. The west elevation is not visible.

It is not know at this time whether there are any of the historic elements on the interior remaining from the original bake house and oven.

8. Narrative Statement of Significance

This commercial building does not appear individually eligible for the National Register of Historic Places under Criteria A, B, or C. The modern installation of the metal facade has significantly altered the historic appearance of this building. Thus, it has lost the integrity need to convey its historic significance. Additionally, the rear and side additions after this building was used as a bake house further have impacted its historic integrity as a bake house. Likewise, the loss of integrity has also impacted its potential contribution to a historic district. With these extensive alterations, the building does not appear to be a contributing building in a potential downtown historic district. However, if the metal façade were to be removed, it could be reassessed for potential integrity and significance.

This building appears to have been associated with the bakery at 201 W. 2nd Street. The 1883 Sanborn shows an earlier as a two section one-story bake house and oven. The 1888 Sanborn maps shows the new bake house and oven as a nearly square, about 30'x25' building with a small rear extension for the oven. The 1892 Sanborn map shows the same layout, and the 1899 Sanborn map shows a rear one-story addition in the space created by the "L" layout. It continues to be depicted as a bake house with oven at 212 Chestnut with this layout on the 1905 and 1912 maps. Between 1912 and 1919, the rear section was rebuilt around the oven section to enlarge this space, demolishing the earlier one-story rear addition to the south and building a smaller one-story addition on this side.

The building at 201 W. 2nd Street operated as a bakery from the 1850s to around 1924. Since an oven is not indicated within 201 W. 2nd St, and this building sits as a bake house on the rear section of the original lot, it seems logically that this building served as the bake house and oven for 201 W. 2nd Street. Also, 212 Chestnut was not listed as an address in the city directories until well after the last bakery closed. J.A. Reuling operated his bakery "J.A. Reulings Oyster Saloon and Bakery" at 201 W. 2nd Street from 1856 to 1875. George Koehler operated a bakery/confectionery/restaurant from 1876 to about 1896. In 1879, Koehler Brothers kept a large stock of confectionery, tobaccos and cigars. Frank Braun operated a bakery and confectionery subsequently to 1907. In 1907, Carl H. Braun operated a bakery and ice cream store from 1908 to 1913. In 1916 Gries and Reich was operating a bakery with Ed Reich taking over in 1919. In 1921 Lyon Bakery was at this location and continued operations until 1924. After this period, 201 W. 2nd Street sat vacant for a few years.

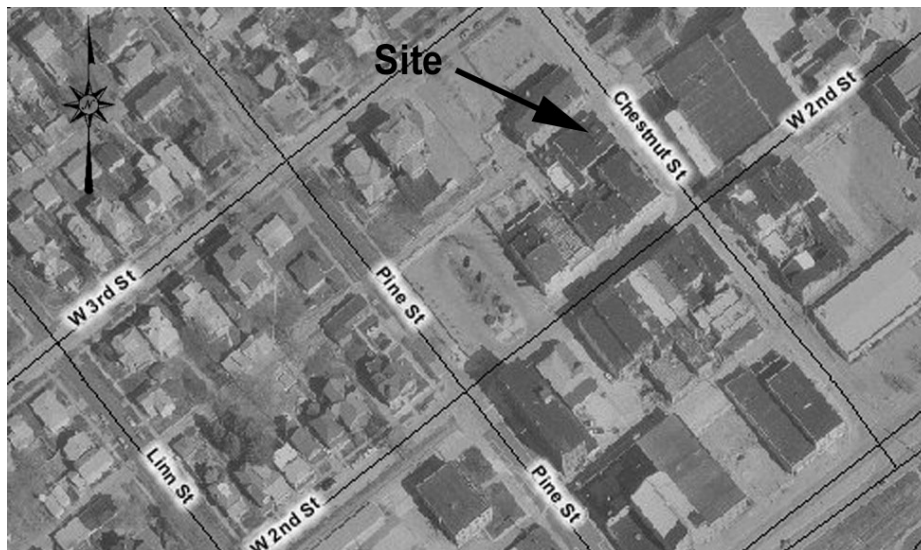
With the closure of the last bakery around 1924, the bake house became obsolete and remodeled as a storage space. The 1928 Sanborn indicates that the building was reconfigured into a shed. It also shows a larger one-story rear addition and a one-story side addition connected to a garage addition to the rear of 201 W. 2nd Street. This layout was retained on the 1946 Sanborn, though the use was now indicated as a "store." In 1962, a city directory listing for 212 Chestnut shows it to be Norton Homer Par Pattern Works.

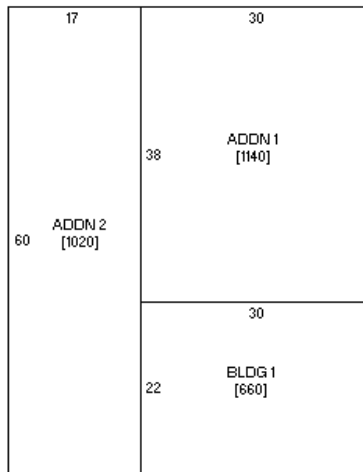
