7. Narrative Description

This gable-front house with a full recessed front porch has been completely clad in stucco. The foundation is also covered in stucco. The front (west) elevation has two bays and a simple gable roof line. A first floor recessed porch is raised and spans the front of the house. The porch has interesting large arched openings. The single-door entry has sidelights, and the door is non-historic. A large group of windows is set to the left of the entry, consisting of a large middle window with narrow window transom above and two narrower single-over-single-light double-hung windows on either side. The upper story windows have single-over-single-light double-hung sashes. The integrity of the windows throughout the building has been somewhat compromised by the addition of metal storm windows. The original wood frames appear to be intact.

The south elevation consists of two sections – the front two-thirds under the straight eave and the back one-third under the peak of the rear cross-gable section. The first story of the front portion contains the side arch of the recessed porch and an adjoining single-over-single-light double-hung window. The front portion has three second-story single-over-single-light double-hung windows, one over the side arch of the recessed porch and the remaining two clustered towards the rear of the front half. The second story of the back portion of the elevation contains a single-over-single-light double-hung window centered beneath the peak of the side cross-gable and an adjoining smaller single-over-single-light double-hung windows set to the west. The first story of back half is occupied by a one-story square bay window that is first depicted on the 1928 Sanborn map. This has a small single-over-single-light double-hung window set near the middle of its south elevation and a larger single-over-single-light double-hung window set in the front (west) face of this section.

The north elevation has three irregularly spaced single-over-single-light double-hung windows in both the first and second story of this elevation. The first story has two of the windows located to the back of the house and one centered between the north arch of the front porch and the back two windows. The second story has one window approximately centered above the two first story back windows and two windows forward of the front lower story window above the porch arch.

The rear (east) elevation has two second-story single-over-single-light double-hung windows and the one-story rear addition. The rear addition does not have a window in its east elevation but it does have a single-over-single-light double-hung window in its north elevation. A single-over-single-light double-hung window immediately adjoins the one-story rear addition in the east elevation of the main house. The house's brick chimney also runs up the two-story section in north corner of this elevation.

8. Narrative Statement of Significance

The Logan House does not appear to be individually eligible for the National Register of Historic Places under Criteria A, B, or C. While the Logan family lived here from its construction and remodeling through 1980. they do not appear to be a particularly prominent family. No important events were found to be

associated with this house. This home has an interesting style with the recessed porch with large arches, front door with sidelights, and large front window set. Its major alterations in between 1912 and 1928 are historic modifications. However, the building, while interesting, is unlikely to be individually eligible for the National Register under Criteria C due to its relatively common features. With the adjacent demolitions of the D.P. Johnson House and Rebecca Hoopes flats, this house remains as the lone residential survivor on this block, which is half commercial. It is not associated with the downtown commercial district, and it is separated from the West Hill neighborhood further to the west. Thus, it does not appear to be within any potential historic district boundary.

The precise construction date of this house is unclear. A two-story dwelling first appears on this site on the 1888 Sanborn map, but the first map to show the house set back from the street line is the 1928 Sanborn map. The 1892 Sanborn map shows a different footprint than the one shown in 1899, suggesting one possible construction date in the 1890s. Charles Logan, and his wife Mary, lived in this house at this time. The 1912 Sanborn map continues to show the same layout, with a two story house, south side porch along two-thirds of the way, rear side extension (bay window?), and one-story rear addition. The 1919 Sanborn map shows the south side wall as straight, with no porch or extension, and the house continues to be set at the front property/street line. According to the Sanborn maps, the house was altered between 1912 and 1919 by reworking the south wall and probably the roof line to incorporate the original south porch area into the house structure. Also, it indicates stucco as the exterior cladding. However, the footprint again changes on the 1928 Sanborn map, and appears to match the current footprint. The house is slightly set back from the property/street line, and a one-story square bay is indicated at the rear of the south side elevation. A wider one-story addition is also depicted on the rear of the house. This suggests a more probable construction, or extensive remodeling, date between 1919 and 1928. Margaret Logan, daughter of Charles and Mary, was living here in this period. The 1946 Sanborn map shows the same footprint as the 1928 map.

Charles Logan, blacksmith with Logan & O'Toole, likely built the original house on this property in 1895. He was listed at this location from 1895 to 1900. Charles was born on May 15, 1858 and died on November 27, 1899, according to St. Mary cemetery records. After Charles death, Mary Logan (widow) continued living at this location with her two daughters Margaret (born 1896) and Luminia (born 1898), and a son Charles (born 1894). She is listed as having furnished rooms at this location from 1900 to 1903, and Elmer Bishop was listed with G.M. Logan from 1904 through 1916, likely as a boarder. The 1910 census indicated Mary was a dressmaker at home. By 1920, Mary's son, Charles, had moved out of the house, Margaret was living at home and working as a teacher, and Lumina was living at home also and working as a stenographer at a hardware store. Mary transferred the house and property to Margaret in 1937 prior to her death (Shank, 2004). Mary, born on March 14, 1863, died on November 10, 1937, according to St. Mary cemetery records. Margaret Logan was listed from 1921 through 1977 at this address, with her death occurring on August 4, 1977. Lumina was listed at this location from 1977 to 1980 with her death occurring on December 20, 1980.

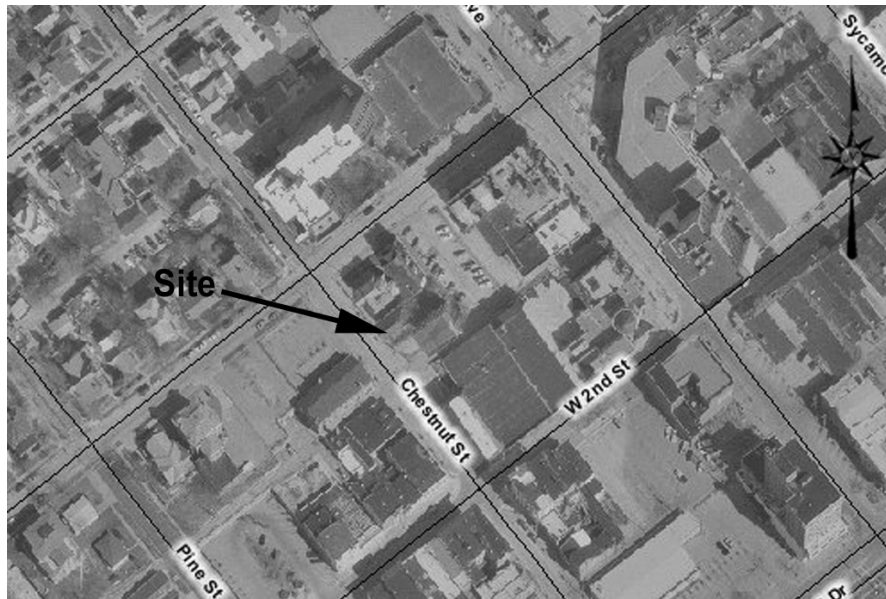

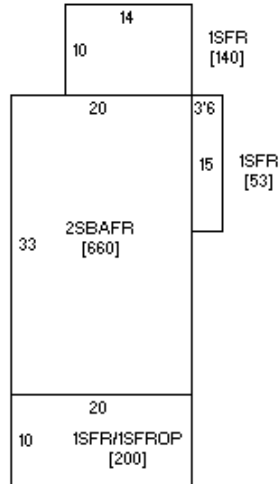
