7. Narrative Description

The appearance of this one-story building dates to a remodel in 1960 when a new front was installed. A 1960 description of the new front appears to be similar to the current appearance ("Employment Office," December 30, 1960, Section 3, p. 12). A photo of that remodel, in the same issue of the newspaper, appears to show the top two floors of the building also removed by this time, probably in conjunction with the new front. The 1961 city directory also lists only 313 E. Second. Prior directories, including 1959, had included 313-1/2 E. Second and listed various apartment tenants. This indicates that the current, remodeled appearance dates to 1960. The storefront consists of a non-historic entry to the right of two large storefront windows. The recessed storefront is angled diagonally back to the entry. The entry has a modern glass door with metal frame and a modern transom window. The two large storefront windows are plate glass with a tall bulkhead clad in brick veneer. A non-historic arch canopy extends across the building. The upper portion of the building is clad in metal panels.

8. Narrative Statement of Significance

This commercial building does not appear to be individually eligible for the National Register of Historic Places under Criteria A, B, or C. The current appearance and integrity of this building date to the 1960 remodel, which removed the upper stories, remodeled the storefront, and remodeled the façade. Though within the period of inclusion for this architectural survey, this is outside the 50-year criterion for eligibility to the National Register of Historic Places. The building was remodeled for the Iowa State Employment Agency. The development of a new storefront not only appears to have been an owner's effort to adapt a storefront to more current designs and needs, but perhaps an effort to improve the image of a state agency.

This building may be a contributing building to the potential downtown historic district, depending on the period of significance for this district. The remodel of this building falls within a strong period of storefront remodels in the mid and late 1950s in downtown Muscatine as owners strove to update their buildings. The alterations are clearly an effort by the building owners to adapt to changing economic trends during the 20th Century and as an example of those adaptations, appear to potentially be a contributing building to a potential downtown historic district.

Prior to the 1960 remodel, this building had a strong historical association with the downtown as a three-story building. The three-story building was constructed by 1883, as the 1883 Sanborn map depicts a three-story structure that is about half the depth of the lot. A sewing machine business was identified as operating from the building. The 1888 Sanborn contained the same footprint, identifying a saloon here. The saloon, which apparently was operated by Crippen & Haifleigh, continued to operate from the building until 1904, when G.H. Weise began using it for a bakery/confectionary. Sometime between 1899 and 1905 the rear stairway was removed from the building and a one-story rear addition added. The confectionary was replaced by 1913 by the Goodyear Shoe Repair. By 1923, J.J. Cavanaugh was operating a men furnishings store from the building. A series of businesses operated here in the 1930s,

including Consumers Wholesale Supply, Schmidt Paint and John Callahan Electric. Between 1943 and 1949, the Lincoln Café was in the building. That business was followed by the B.F. Goodrich Tire Store, which stayed at that site until around 1957. The last Sanborn map for Muscatine, in 1946, continues to show a three-story building at this location.

After standing vacant for about one year, the Iowa Employment Agency located there in 1959. Extensive remodeling was done on this building in 1960, removing the top stories and installed a new front ("Employment Office," December 30, 1960, Section 3, p. 12). Surprisingly, after the extensive remodeling that was done, the state agency only stayed in the building for one year. The Big Dollar Redemption Center opened there in 1962 and remained there until 1967.

A gift shop and other businesses operated there in later years, with the present restaurant and pizza business opening there around 1994.


