7. Narrative Description

This is a three-story, one-bay, brick commercial building. The storefront entry is recessed at the left side of the storefront. It has a historic wood door with a window and a transom window that has an air conditioning unit inserted into it. An entry to the upper stories is located to the right of the large storefront window. This door also appears historic, with three lower panels and an upper window. Vertical wood paneling painted blue clads the lower and upper portions of the storefront. The storefront was remodeled at the same time as the neighboring 218 Walnut, and share the same design and detailing. The paired windows on the second and third stories are centered on the building. The paired windows have non-historic double-hung sashes. A wood mullion separates the windows, and carved detail is found in the segmental arch portion of the top of the window frame. Segmental brick arch lintels with shoulders span each set of paired windows. The frieze is defined by courses of slightly projected brick along alternating projected rowlock bricks on the top and bottom of the frieze. The rear of the building has been clad in vinyl siding. A two-story rear addition is also clad in vinyl siding. A balcony provides direct access to the second story.

8. Narrative Statement of Significance

214 Walnut Street does not appear individually eligible for the National Register of Historic Places under Criteria A, B, or C. However, it appears to be a contributing building in a potential downtown historic district. None of the business or people associated with 216 Walnut appear to be particularly significant. Several meat markets operated in Muscatine in the 1890s and early 1900s, and this market does not appear to be particularly prominent. The architecture is typical of the 1890s in Muscatine, without particular distinction. Thus, it does not appear to be individually eligible for the National Register of Historic Places under Criteria A, B, and C.

However, this commercial building does appear to be a strong contributing building in a potential downtown historic district. It falls within two historic contexts identified for the district: "19th Century Business and Industry" and "20th Century Business and Industry." Its use as a meat market represents a needed business in downtown Muscatine to serve its residents and it contributes historically to the potential downtown district.

This commercial building was constructed around 1890. The 1888 Sanborn map depicts a vacant lot here, but the 1892 Sanborn map shows a narrow three-story building. Tobacco is depicted as the use at this time, though its association with a specific business could not be identified. The 1895-96 city directory lists the Mohnsen & Kreiger meat market at this address. Hans Mohnsen lived above 220 Walnut, where he previously operated a restaurant. Amos Kreiger lived above 216 Walnut. Hans Mohnsen continued to operate a butcher shop here according to the 1897-98 city directory, while also using the 220 Walnut storefront as a liquor store. Mark Quinn, a clerk for B.E. Lilly, lived above 216 Walnut in the late 1890s and early 1900s.

In 1900, August Unkel's meat market was listed at 216 Walnut. By 1907, he and his wife had moved into the upper stories. This meat market is one of 14 listed in the 1923-24 city directory. By the late 1920s, Carl P. Rauch worked as a meat cutter for Unkel. When Unkel retired or died, he continued the business, and the 1934 city directory lists Carl P. Rauch – meats, at this location. The upper stories were rented out at this time, and tenants continued to turn over through the 1940s. In the 1938-39, Rauch is listed as offering groceries and meat. He apparently continued this business until around 1950.


The 1952 city directory lists 216 Walnut as vacant. Mabel's Photo and Novelty Shop was here briefly in 1954, and The Quilting Shop was here briefly in 1958. In 1965, Price's Floor Covering at 214 Walnut was using 216 as storage space. It is currently associated with Willy's Pool Hall at 218 Walnut.
