**Amend Agenda**- Daufeldt requested to amend the agenda to add Gregg Mandsager in order to explain to the board members about the Library budget and the CAT Grant. Regennitter moved to approve the agenda as amended. Second by Olson. All ayes. Motion carried.

**CAT Grant and Library Budget-** Mandsager provided the board with some basic background on the Pearls of Progress Project as well as the CAT Grant process. Additionally, he explained that since the new library building renovation is part of the CAT Grant, the CAT Grant Committee requires a resolution as evidence that the Board is committing the \$100,000 from trust funds towards the project.

Collins added that the \$100,000 trust contribution is not a new contribution but has been a part of the budget for the project from the initial budget. A portion of these funds, such as much of the architectural fees, have already been expended from the Trust and these expended funds count towards this \$100,000 commitment. Additionally, it is possible that the CAT Grant Committee will accept other contributions in place of some of this funding if the fundraising effort is successful.

Request to Adopt Resolution Committing Library Trust Funds to the New Library Building Renovation Component of the Pearls of Progress Project - Daufeldt requested a motion for the signing of the resolution. Dew moved to approve the signing of the resolution. Second by Olson. All Ayes from Olson, Dew, Regennitter, Moravec, Daufeldt, Gordon (via phone) and Wojetecki (via phone). Motion carried. Resolution attached.
